## **Tesla Ride and Drive Day**

A ride and drive day in Edgecombe-Martin County's new electric vehicle will be held on Wednesday, November 10.

Edgecombe-Martin County EMC is not in the car business, but we are in the business of providing education and awareness to our members about the growing electric vehicle (EV) industry, which has significant impacts on electric utilities. Electric vehicles are less expensive to fuel than gasoline powered vehicles. The average person drives between 10,000 and 15,000 miles and spends between \$1,000 and \$1,500 on gasoline per year. In comparison, the cost of electricity to power a Tesla Model 3 over the same distance is up to four times lower. Over the six-year average length of car ownership, that's between \$4,300 and \$6,400 in gasoline savings.

In order to provide firsthand education and awareness about the quickly growing electric vehicle industry, we recently purchased a Tesla Model 3 and we want you to try it! The Tesla is an all-electric, zero-emission vehicle with a range of 353 miles. If member-owners are considering an electric vehicle or are just curious and want to test drive one, we encourage you to participate in this event. Participants will also have the opportunity to speak with employees about our EV rates and rebate programs.

Test drives will be by appointment only, Wednesday, November 10, from 10 a.m. to 3 p.m. at the co-op's headquarters. Members wishing to participate must have a valid driver's license and proof of insurance (liability and collision).

This very detailed and thorough process needs to be completed periodically to ensure fair and equitable rates and your cooperative's financial stability into the future.

As in most businesses, costs continue to rise on many of the items necessary to conduct business. Materials, equipment, insurance, and benefits have all seen their share of increases over the past four years. Much like the increasing cost of the goods we purchase for our homes and family, the cost of the Cooperative's materials and supplies used for our operations and maintenance have also increased. These increases are in addition to the escalating power cost due to increases in the cost of coal, its transportation, and associated environmental compliance.

We strive to maintain and improve our electrical system so we may continue to provide you with the reliable electric service you have come to expect. Edgecombe-Martin County EMC monitors and evaluates the cost and expenses needed to provide safe and reliable service to our members. Budgets and contracts are reviewed annually and adjusted to meet the ever changing system and business needs to provide quality service to our members without jeopardizing reliability and safety.

# Detached Ductwork Can Lead to High Bills this Winter

When was the last time that you ventured into your home's crawl-space or attic to inspect your HVAC system's ductwork?

If it has been a while, then it would be a good idea to slip on some old work clothes and have a peek at the condition of the ductwork in these seldom seen areas.

Ductwork should be inspected twice a year; once before you turn on your cooling system in the summer and once more before you begin using your heating system. Ducts often fall or become detached due to improper installation techniques. Mastic sealant is the only thing that should be used to seal ducts to register boots and plenum connections.

HVAC or duct tape should NOT be used. Over a period of time, these tapes will lose their adhesive properties allowing ductwork to fall down in the homes crawl-space or attic. When this happens, all you are doing is dumping conditioned air, that you paid good money for, under your home or in the attic!


So, take a few minutes and survey your ductwork before it cost you high energy bills this winter.

# Add an LED Area Light to Extend Your Day

Daylight Savings Time ends this month, and that means it will be dark earlier.

With days getting shorter and nights growing longer, outdoor lighting can help you better utilize your outdoor space during the fall and winter months.

Edgecombe-Martin County EMC offers LED lights that come on automatically at dusk and go off at daybreak. Maintenance is handled by Edgecombe-Martin County EMC and does not cost the member extra on top of the monthly security light charge.



Installation of any security light requires a deposit of thirty dollars. A 48-Watt LED light on an existing pole is \$9.72 per month; a 98-Watt LED on an existing pole is \$10.40 per month.
